of the High Court of Malaya**

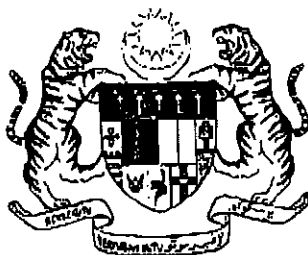

Kindly take note of this matter and advise your pupils accordingly.

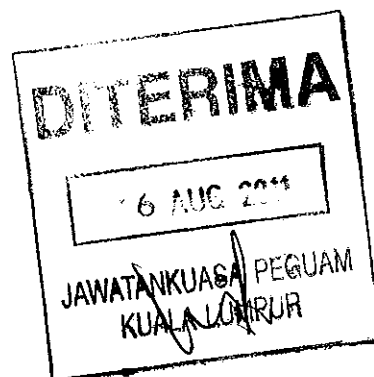
